







### PRODUCT DESCRIPTION

Insulators, as one of the main components for the external insulation of transmission lines, are used to support or hang conductors so that they work where there are towers, and ensure that lines have reliable electric insulation strength. The product consists of a Hot dip galvanized cast iron fitting, tempered glass moulded form and steel pin, which are bonded together by cement and cotter key. They are manufactured at high temperatures by

mixing the different materials and then rapid cooling in the mould. This action "Toughening causes tightening of the glass. It's mechanical and Electrical parameters confirm to IEC60383 Glass insulators have been widely used in power systems because of their excellent electrical properties, anti-corrosion properties and mechanical strength.



## **MANUFACTURING AND PACKAGING (A1-A3)**

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission. Cap, key, pin and cement are purchased from suppliers. Glass moulding and finishing is done in house. Assembly of purchased components is done after glass moulding as shown clearly in the

manufacturing process below, all raw materials are considered, packing labels which constitute less than 0.5% of the total mass are not considered.

### **TRANSPORT AND INSTALLATION (A4-A5)**

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

Based on sales data of each type of insulator average shipping distance is calculated and from port to customer's site 50 km is considered as average distance.

Installation waste (A5) – All installations are in Norway, Sweden mainly.

Wooden pallets are sent for incineration.

85% recycling rate for packing strip and nails is considered according to the lifecycle impacts of European buildings, and the remaining 15% is sent for landfill.

### **PRODUCT USE AND MAINTENANCE (B1-B7)**

This EPD does not cover the use phase.

Air, soil, and water impacts during the use phase have not been studied.

## PRODUCT END OF LIFE (C1-C4, D)

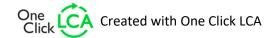

Installation of product is done manually however we have considered 0.01kwh/kg as standard as energy used in removing the insulator (energy consumption during demolition) from the line. As Insulators are used in Norway and Sweden transport by lorry (16-32 Metric tons) class Euro 6 and distance as 50 kms is considered. For Steel Scrap 85 % can be recycled reference World Steel Association (pg19, 2020) & 15 % goes to landfill. Cement goes to landfill.

Glass recycling is considered as 100 %.





There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.
